5. Department Reports

a. Public Works - Gary Coffman, Public Works Supervisor Projects included: snow removal, ice rink installed and repaired, new shop lights installed, frozen water meters replaced, Christmas decorations taken down. He stated Mike and Shane from Shive Hattery Engineering will be at the next meeting to discuss the water storage study.

b. Police - Police Chief Jason Heimdal

Chief stated it was quiet over the holidays. He mentioned Officer Sand had an accident with the Charger and it slid down into a ditch. The estimate for repairs is approximately \$8700. He hasn't heard from the appraiser yet. Mayor asked Chief to check around town for nuisance junk cars.

6. OLD BUSINESS

a. Tax Abatement update

Hibbs reported the paperwork for the tax abatement is now with the attorney. We need to provide assessed valuations of the real estate in the URA from the county assessor's office. When we are ready for public hearing, notices need to be sent to landowners and occupants informing them the hearing.

7. NEW BUSINESS

a. 2017 Earlham Fire Department Annual Report – Chief Shawn Boyle Chief stated the department responded to 94 calls in 2017. The department has 23 active and 2 reserve fire fighters. Members logged 662 hours of training. New truck was purchased in May. Received new radios through grant in conjunction with Statewide Interoperability Communications Network worth \$58,000. Participated in various civic activities during the year.

- b. 2017 Earlham Rescue Squad Annual Report Captain David Hopp
 Captain stated responded to 213 calls in 2017. The department has 17 members which includes 8

 EMTs, 4RN, 1 paramedic and 4 drivers. Participated in several community events.
- c. Discussion and possible action on future of Old Fire Station
 Chief Boyle says the structure is unstable. Almost 30 years ago it got a facelift through the TV8
 Project Main Street Grant. But it hasn't been maintained since that time. It is used for storage of antique equipment and other items.
- d. Update on possible purchase of 150 S Chestnut Avenue Mayor, Chief and realtor Jim Cress recently toured the building. Mayor stated Public Safety Committee should meet to discuss and form recommendation to Council. Public Safety meeting is set for Wednesday, January 10, 2018 at 7:00 p.m.
