The Earlham City Council met in regular session on Monday, March 11, 2019, at Earlham City Hall. Coffman said work on residing and reroofing the city shed, from the hail damage, is complete. He also mentioned that while clearing snow from the Community Building parking lot, the flatbed truck hit the east side of the fire station. The claim has been sent to the insurance company.

Chief Heimdal reported there were 10-12 snow parking tickets last month. Met with Madison County regarding getting Automatic Defibulators in all patrol calls in the county.
