## Special Session Earlham City Council Meeting August 16, 2021

The Earlham City Council met in special session on Monday, August 16, 2021, at Earlham City Hall. Mayor Lillie called the meeting to order at 7:00 p.m. and the following answered roll: Baskin, Fredericksen, Payne, Petersen, Swalla. Also present: Clerk Hibbs.

1. Approval of Agenda

Moved by Baskin, second by Fredericksen, to approve agenda.

2. Consider approval of First Reading Ordinance No. 431 Amending Chapter 116 of the Code of Earlham, Iowa, Adding Section 116.17 Price of Columbarium Niche, and Section 116.18 Interment of Cremains in Columbarium.

Discussion held on regular cemetery spaces in surrounding communities, which are running \$400 to \$500. Very few columbaria in this area to compare to. Council felt price of cemetery space should be increased to \$500 (\$700 non-resident) as the number of spaces is dwindling. Niche spaces in the columbarium will be the same as cemetery spaces.
