CONTRACT FOR CONCRETE COATING SERVICES

This Contract ("Contract") is entered by and between Revival Concrete Coatings, LLC, hereinafter referred to as the "Company," and the below signatory, hereinafter referred to as the "Buyer(s)."

1. Preparation:

The installation process includes site preparation and the supply and installation of products described in this Contract, along with any ancillary hardware. The Company will be responsible for removing job-related debris to the best of its ability.

2. Customer Responsibilities:

The Buyer(s) shall be responsible for making suitable arrangements for the relocation of any gas, electrical, wiring, plumbing, or telephone installations at their own cost prior to the commencement of work. Furthermore, the Buyer(s) shall obtain any necessary permits required for the Company to perform the work outlined in this Contract.

3. Liability Disclaimer:

The Company shall not be held responsible for any injuries incurred due to slip and fall occurrences resulting from slippery surfaces under certain conditions. While the product is slip resistant, the Company does not represent that it is slip proof. It is the Buyer(s)' responsibility to ensure their own safety and the safety of their guests and invitees.

4. Payment Terms:

The Buyer(s) agree to make payment in cash according to the terms outlined below, or by signing a note provided by the Company if credit is approved. Failure to adhere to the payment terms shall result in the entire unpaid amount becoming immediately due, along with a collection cost equal to the Company's actual costs of collection, not exceeding 15% of the total amount owed, plus attorney's fees and court costs. The Company may enforce a claim against the Buyer(s)' property in accordance with applicable lien laws for non-payment.

5. Payment Methods:

For credit card payments, the balance due shall be automatically charged upon completion if permission was granted by the Buyer(s). For payments made by checks or cash, the balance shall be collected by the crew foreman. Finance charges shall be assessed on all balances outstanding for over 30 days in accordance with applicable law.

6. Cancellation Policy:

The Buyer(s) reserve(s) the right to cancel this transaction at any time before midnight Central Standard Time of the third business day following the date of this Contract. This sale is subject to the provisions of the Home Solicitation Sales Act and the Home Improvement Act.

7. Indemnification:

The Buyer(s) shall indemnify, defend, and hold harmless the Company, its officers, directors, employees, and agents from and against any and all claims, liabilities, damages, losses, costs, and expenses, including reasonable attorney's fees, arising out of or in connection with any breach of this Contract or any negligent or willful act or omission by the Buyer(s) or their agents, employees, or subcontractors.

8. Installation Date Change Penalty Disclaimer:

This Contract stipulates the penalty applicable to changes made to the installation date within two weeks of the agreed-upon installation date. Except for force majeure events, rescheduling due to moisture, or weather conflicts, any alterations to the installation date falling within the this timeframe shall incur a penalty fee equivalent to 10% of the total installation cost.

9. Permits and Licenses: Upon request, the Company shall provide all necessary permits and bonds for the completion of the concrete coating services.

10. Applicable Law: The context of this Agreement shall be interpreted with the laws of Nebraska.

11. Entire Agreement:

This Agreement constitutes the entire understanding between the parties, superseding any verbal agreements. The Buyer(s) acknowledge(s) having read, understood, and received a completed, executed, and dated copy of this Agreement, including attached Notices of Cancellation, on the date first written above.

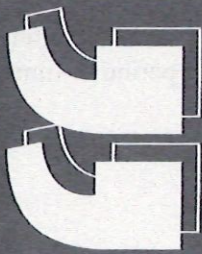

TO PREP THE AREA:

- Make sure the area is clear and dry. Please remove floor coverings the day before to allow the concrete to dry underneath. (Ex: mats, plants, rugs, carpet and tile)
- Although our vacuum systems contain 90% of the dust generated, please remove any items you want additionally protected or cover them with plastic or a tarp.
- Avoid parking on the floor the night before installation if it has been raining or snowing to avoid pooling water or melting snow.
- If we are installing an outdoor project for you and you need to mow, please do so at least 48 hours before we arrive to avoid grass blades getting in your coating.
- If you are having your patio or pool deck done, please run an edger around the edges of the concrete at least 48 hours in advance to allow us to curl the coating. If you do not cut this in advance we can't curl around the edges. If you have mulch or rocks please pull them back to allow us to coat up next to the concrete.

WHEN THE INSTALL IS COMPLETE:

- Do not close the garage door fully until at least 12 hours after the install. You may drop the door a few inches above the floor.
- Allow a minimum of 12 hours before walking on the floor.
- If it's 25 degrees or warmer when we install, you may drive on the floor 24 hours after the install is complete. If it was cooler than 25 degrees, please wait 36 hours.

ONGOING MAINTENANCE AND CARE:

- Sweep off sand and salt then simply rinse with water. A squeegee works great to clear water off.
- For a sparkling clean, we recommend using Simple Green, PineSol, or Dawn Dish Soap mixed with warm water to clean your floor.
- For tougher cleaning let the cleaner sit on the floor for 5-10 minutes and scrub with a scrub brush or stiff bristle broom. Wait an additional five minutes and follow up with another rinse for a revitalized floor.
- For difficult stains pour a small amount of denatured alcohol on a rag and wipe the area.
- Clean up chemical spills as soon as you notice them.
- Avoid long term exposure to bleach and stay away from acids and highly corrosive materials.
- Although the coating is very strong, do not drag any metal objects across the surface. For example, use a kick plate under a motorcycle stand and do not drag/slide a refrigerator or freezer across the floor.
- For patios and porches, please use a plastic shovel or broom to remove snow.
- For patio projects, be cautious of leaving furniture or rugs in the same place for extended periods of time in the first year. Like hardwood floors, there can be a slight fading the first year, but after that it will stabilize.
- Avoid using any tire shine/tire cleaning products (Armor All, Meguiar's, Black Magic, etc.) this can cause a yellow stain on the coating.
- Please be cautious of leaving any metal tools and/or equipment directly on the coating. Rust can stain your coating if left sitting over a long period of time



5 YEAR COMMERCIAL WARRANTY

Revival Concrete Coatings, LLC Commercial Warranty

When installed by a Revival Concrete Coatings, LLC installer, the materials are warrantied for a 5 year duration of the coating. The materials and labor have a 5-year warranty for the original owner and subsequent owners under the same conditions stated herein, covering delamination from properly prepared substrates, peeling, chipping and/or blistering of the coating. The sole liability is limited to replacement of any product shown to perform otherwise than as warrantied. This warranty is applicable to commercial applications only and is dependent on the following conditions:

1. This warranty does not apply to any damages to the coating by physical abuse, gouging, excessive force, high pressure washers, failure of the structure or substrate, vandalism, modifications to the substrate the coating is being applied, mechanical impact damage, exposure to heat or flame, exposure to solvents and/or acids, windstorms, lightning, nails, screws, plant life, animal life, abuse of owners, or any other acts of God, and other extensive damage beyond the scope and protections of the system applied.
2. This warranty does not apply to damage caused by a hydrostatic water problem, moisture vapor permeating the concrete slab, or exposure to either battery acid or brake fluid. This warranty does not cover changes or oxidation of the coating as a result of normal weathering or atmospheric conditions.
3. This warranty does not apply to delamination caused by improper substrate condition, or an internal failure of the substrate.
4. This warranty does not apply to damage caused by cracks in the substrate prior to or occurring after the installation of the floor coating system that appear from ground shift and/or expansion/contraction of the substrate. Cracking due to substrate movement is not under warranty regardless of whether the same was repaired during original installation or not. There is no warranty for cracks or crack repair regardless of cause. This limited warranty shall not apply in the case of improper substrate construction, exposure of the products to solvents and/or higher concentrations of acids other than that moisture from within, under or adjacent to the concrete surface.
5. Revival Concrete Coatings, LLC does not warrant how level the floor will be after the coating is installed. We repair cracks, pitting, and chipping; however, this is not to be considered leveling or grading of the concrete slab. You could experience pooling of water on your floor after putting on a coating if your floor was unlevel.
6. Areas repaired under this warranty may vary in color and texture from areas originally installed which are not repaired. Revival Concrete Coatings, LLC shall not be responsible or liable for matching color or texture for repaired areas versus unrepaired areas.
7. Products must be applied on a properly prepared surface in accordance with standard product specifications and application procedures.
8. Revival Concrete Coatings, LLC will not be liable for consequential or incidental damages of any kind including, but not limited to, damages to the structure or its contents resulting from defects in a coating system. The obligation assumed under this warranty is expressly limited to providing such materials and labor (as provided herein) required to repair any defects covered under this warranty.
9. The responsibilities under this warranty agreement cease if any alterations, additions, or repairs (excluding emergency repairs) are made except in accordance with specific written instructions from a Revival Concrete Coatings, LLC Representative.
10. Any notice of claimed defects in materials shall be sent in writing by certified mail, return receipt requested, to Revival Concrete Coatings, LLC, 6950 NE 14th St, Suite 31 Ankeny, IA. Failure to notify Revival Concrete Coatings, LLC in writing as provided above of any such claimed defects within 30 days of discovery of the claimed defect shall void the warranty claim.
11. Purchaser shall allow a Revival Concrete Coatings, LLC Representative up to THIRTY (30) DAYS to inspect and provide replacement materials under this warranty. Revival Concrete Coatings, LLC may, at its request, require photographs, invoice copies, or other information/documentation about the claimed coating failure.
12. This warranty becomes effective only upon payment in full to Revival Concrete Coatings, LLC for all outstanding charges relating to this Project ID.

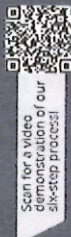

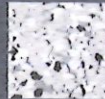

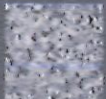
